



Title: End of Sale for Message Networking R2.0 on S3400 HA for European Union Countries. - UPDATED

Notification Date: April 17, 2006

To conform to the Restriction of Hazardous Substances (RoHS) directive set by European Union countries Avaya will no longer offer the Message Networking (MN) R2.0 Enhanced Offer that is delivered on the S3400 High Availability server.

For the purpose of the End of Sale notice, European Union countries will pertain only to the specific European Union countries in which Avaya has made Message Networking (MN) R2.0 Enhanced Offer that is delivered on the S3400 High Availability server available. These countries are: Austria, Belgium, Czech Republic, Denmark, France, Germany, Hungary, Ireland, Italy, Luxembourg, Netherlands, Portugal, Slovakia, Spain, Sweden, and United Kingdom.

Effective **April 3, 2006** Avaya will no longer allow new quotations or orders of the Message Networking R2 Enhanced Offer on S3400 HA hardware in European Union countries..

Avaya will continue to offer:

- For non-European Union countries, New System sales of Message Networking (MN) R2.0 Enhanced Offer that is delivered on the S3400 High Availability server.
- For European Union and all Countries, System Additions (analog networking and features) for the Enhanced Offer for existing systems.
- For European Union and all Countries, New System sales of Message Networking (MN) R2.0 Basic Offer that is delivered on a standard availability server. Avaya will introduce a new S3210R server which will be RoHS compliant to support the Basic Offer. This will be addressed in a separate EoS notice specifically for MN R2.0 on the S3210 server.
