With the General Availability (GA) of Modular Messaging Release 3.0, Avaya will End of Sale software media, licenses, and hardware for new system sales of Avaya Modular Messaging Release R2.0 with the Avaya Message Storage Server (MSS).

Effective **July 30**, **2006** Avaya will no longer allow new quotations or orders for new systems sales of Modular Messaging R2.0 with the Avaya Message Storage Server (MSS).

REVISED: Effective **July 30**, **2007** Avaya will no longer allow new quotations or orders for additions and expansions to existing systems of Modular Messaging R2.0 with the Avaya Message Storage Server (MSS) that require Avaya Modular Messaging hardware.

REVISED: Effective July 30, 2007 Avaya will allow seat license additions to existing Modular Message R2.0 systems provided additional Avaya hardware is not required to support the addition. Refer to the SAP Codes Available for Aftermarket Expansions/Additions section of this document for details.

Note that in a previous End of Sale announcement targeted at sales in the European Union, Modular Messaging R2.0 with the Avaya Message Store Sever (MSS) was discontinued, effective April 3, 2006, to comply with RoHS regulations.
